PURPOSE OF CHALLENGE:

This competition aims to showcase and elevate the skills, creativity, and professionalism of aestheticians. It provides a platform for participants to demonstrate their expertise in various beauty treatments and techniques, such as facials, manicures, body treatments and makeup, fostering a spirit of excellence and innovation within the industry. Through rigorous assessment by industry experts, these competitions not only celebrate outstanding talent but also set high standards, inspire continued education, and highlight emerging trends. Ultimately, they contribute to the advancement and recognition of the beauty therapy profession while demonstrating professionalism and complying with occupational health and safety.

Aesthetics Criteria

Please review the attached information prior to the competition

Competitors will be judged on the following for all competitions:

Sanitation, ethics, professional dress, attitude, behavior, conduct with model, posture, technique, application, finishing and total look.

Skills and Knowledge to be tested

Advanced Facial

The competitor will showcase an advanced facial routine, featuring the application of cleanser, exfoliant, toner, serum(s), mask and finishing products.

The facial will include the use of BT Sonic for cleansing (link to video found [here](#)) and BT Micro for infusion of serums (link to video found [here](#)), Lymphatic massage video found on SCC website. and Cold Globes to soothe redness and decrease inflammation. Competitors may use their chosen massage movements to complete the cold globe movements. [SCNC25 30PS Lymph Drainage 1 Angle FR.mp4](#)

Participants will demonstrate lymphatic drainage techniques on the face, followed by a relaxing massage covering the face, neck décolleté and neck & shoulders.

Creative Makeup: Seasonal Fusion

In the seasonal fusion creative makeup challenge, competitors will skillfully blend the essence of two chosen seasons (50/50 split to each season chosen) onto the face and décolleté ending two inches below the clavicle.

Competitors will bring all their own art medium to create their entire look (no pictures or stencils are to be used to complete the look) See example pg. 5

The task is to skillfully blend the essence of two chosen seasons onto the face and décolleté (50/50 split of the two seasons). Competitors can choose any two seasons.

The judging will focus on creativity, technical skill, color harmony, theme representation, and overall impact. The goal is for each competitor to leave a lasting impression by creating a stunning fusion of two seasons.

- Advanced Facial- lay down beds, hot towel cabbies, trolley, magnification light (head or floor model) step stool BT Sonic, BT Micro, facial globes* no additional equipment to be used

Advanced Facial

Creative Makeup

All necessary supplies, linens and tools/brushes need to perform makeup application (such as cotton buds, cotton rounds, white headband, cape/wrap, etc.).

The following list of required facial products to be sponsored by L'Moor. * Competitors will not be able to bring any other facial products on the competition floor.

Cleansing Milk, Hydrating Toner, Hydrating Cream and gauze

*Please note that only 4-4x4 gauze and 2 medium towels are to be used. Additionally, PPE for this scope is optional.

WORKSITE SAFETY RULES / REQUIREMENTS:

- All competitions will take place on live models. Competitors are responsible for supplying their own model and for the well-being of their model
- **Model must meet all component criteria** to ensure compliance with the rules and regulations
- A scrutineer at the start of each competition will examine all models. **No prep work permitted**
- No competitor shall continue to work on his/her model once the competition has ended
- Any infraction or violation of the competition rules will result in point penalties or disqualification
- Model must be dressed in clothing that allows competitor to perform components.

General Competition Rules

- All competitors will **attend a mandatory orientation** meeting prior to the start of the competition. (7:45-7:55am). **Failure to attend orientation will lead to disqualification**



All competitors **must** wear a black professional uniform with **no** school logo (NO leggings or yoga style pants). Black non-slip flat or low heel, professional closed toed shoes with black socks. Hair must be tidy and tied back and off the collar and face. Competitor must not have jewelry and have short, manicured, non-polished nails

- Competitors who require clarification on instruction during the contest must address their questions to the Provincial Technical Chair or designate
- Competitors are not permitted to talk to persons who are not located within the contest area
- Interpreters will be allowed to access the contest site if previous arrangements have been made with the Provincial Technical Chair or designate
- During the competition competitors may go to the restroom only after informing a Provincial Technical Chair. Escorts to restroom will be at the discretion of the Provincial Technical Chair or designate
- Competitors must follow workplace safety rules and regulations as outlined during orientation
- Access to each contest site is reserved for the Provincial Technical Chair or designates, judges, competitors, and individuals that have been granted permission from the Provincial Technical Chair or designate
- All competitors shall allow the Skills Manitoba organization to take and publish photos of those individual competitors
- There must be a minimum of five registered competitors. If there are less than five registered competitors, Skills Manitoba delegates will re-evaluate the competition
- No competitor shall begin work until the start time is announced
- Skills Manitoba will make every effort to accommodate persons with medical conditions or impairments. Please contact the Skills Manitoba office for details.

| 15 minutes | Pre-service set up Professional Appearance Treatment area and competitor prepared for facial. This includes product set up. Competitor must prepare themselves as per the contest description to begin the service |
| 3 minutes | Checkpoint for Judges |
| 20 minutes | Model greeted and installed, review client intake form and perform eye & lip cleanse Model is greeted and therapist offers assistance and care, as needed, to the service area. Model is installed with adequate draping to provide comfort, warmth and modesty. The competitor must review model's intake form and perform a verbal consultation to ensure there are no contraindications and give a brief explanation of the treatment. Eye & lip makeup is removed with no traces of mascara or lipstick left |
| 5 minutes | Checkpoint for Judges |
| 15 minutes | First cleanse, skin analysis, record findings and product selection * see pg. 10 skin analysis First cleanse is performed. Skin analysis completed with the magnifying lamp. Findings to be recorded on the forms provided. Competitors will choose the correct products to complete the facial based on the findings recorded during the skin analysis |
| 10 minutes | Checkpoint for Judges |
| 15 minutes | Second cleanse, with BT Sonic, exfoliation application and removal Second cleanse performed using the BT Sonic. Competitors must demonstrate proper techniques while using the BT Sonic. Skin is exfoliated. Area to include the face, neck & décolleté. Exfoliant removed leaving no residue on the model, bed or linens |
| 5 minutes | Checkpoint for Judges |
| 10 minutes | Serum application & infusion using BT Micro Serums will be applied to the model and then infused using the BT Micro. Competitors must demonstrate proper BT Micro infusion techniques |
| 5 minutes | Clean station, disinfect BT Sonic and BT Micro, prepare for massage Competitors will demonstrate the proper health & safety protocols to clean up their station. BT Micro & BT Sonic will be disinfected according to health & safety. Prepare for lymphatic drainage massage and demonstration of cold globes |
| 15 minutes | Lymphatic Drainage Demonstrate the correct sequence using the provided step by step instructions (SCC website) of moves with a light flowing movement, draining the lymph fluid towards the lymph nodes. The lymphatic drainage massage will be performed on the face, neck and décolleté |

Mask is removed as per sponsors instructions leaving no residue on the model's face, and hair. While the mask is on, a scalp massage will be performed. Competitors will use a scalp massage medium and perform massage for 10 minutes. Correct pressure must be applied with smooth, rhythmical movements, without breaking contact with the model. A variety of massage techniques must be incorporated |
| 3 minutes | Checkpoint for Judges |
| 20 minutes | Finishing products, after care, model exit and station cleanup Application of finishing products. Provide verbal after care advice to the model. Assist model to the change room and waiting area to exit. Cleanup treatment area. |

Makeup Sanitation Procedure How To

1. Make sure all brushes and implements are clean and disinfected prior to the service
 2. All cream/liquid products must be dispensed using a clean spatula onto a clean palette.
 3. Powder makeup products may be sprayed with 70% alcohol prior to use for disinfection purposes.
 4. Liquid eyeliners cannot be disinfected, if being used the product must be new (in packaging) and either disposed of or given to the model afterwards.
 5. Do not double dip mascara spoolies as these are one time use only.
 6. Alcohol activated cream paints may be used as the alcohol will disinfect the product each time it is sprayed.
